2019 Operating Fund Goal: \$1,365,000

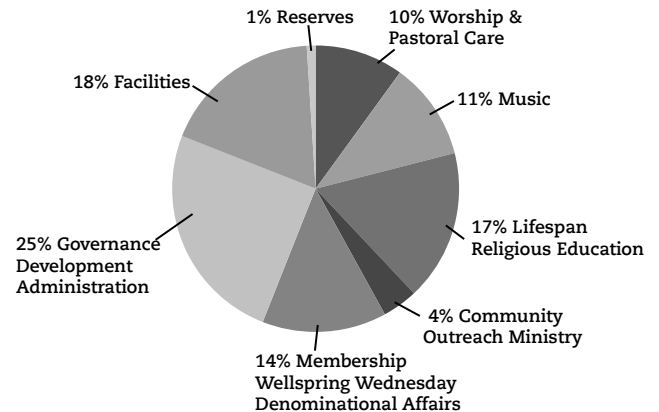

Capital Pledges

Ongoing capital pledges allow us to repair and maintain our sacred home, and to pay debt service on the loan from our 2012 *Unity Tomorrow* project.

- In 2018, capital pledges made it possible to purchase teal hymnals and new church software, commission a stained glass window for the Parish Hall, repair our Sanctuary roof and steps at the southeast entry, and pay for year two of debt service.
- In 2019, capital pledges will allow us to install panic hardware on the interior Sanctuary doors, make other capital repairs and acquisitions, and pay for debt service.
