What You Need to Know about COMT's, Staff & You!

January 2024 with Rev. Kathleen Rolenz and Rev. KP Hong

The Community Outreach Ministry Teams were created to further the ministry of Unity Church in service to the larger community. The purpose of this Q & A is to answer some questions that have arisen since Fall 2023 about budget, honoraria, policy, procedures, etc.

When is our next COMT Application due?

All COMT applications for new and/or continuing COMT's are due by September 1, 2024. The application form can be found here.

Can my COMT be the recipient of a Sunday Morning offering? If so, when?

At the last COMT Summit, the Executive Team proposed and implemented the idea that all COMT's were eligible to receive a yearly offering. These monies would go to the COMT to sustain their work, to purchase supplies, to pay for guest speakers at programs and/or to be used in whatever way they decide to support their programs. Please be aware that scheduling at Unity church is complex! The more advance notice you give the staff, the more likely we can accommodate your event/request.

Our COMT would like to meet in between services on Sunday AM, or on Wellspring Wednesdays.

Space is at a premium on Sunday AM's, particularly between services. Generally, we cannot schedule COMT meetings between the 10:15-11:15 church hour. Meetings AFTER the 2^{nd} service during the church year are not a problem. Re: Wellspring Wednesdays: Generally, we try not to schedule meetings during Wellspring Wednesdays.

Our COMT would like to meet on-line.

If you are unsure or have any questions, set up a time to meet with Heidi for a brief training on how to navigate your meeting on-line.

For all newsletter items, the deadline is the 15th of each month. Martha often receives communication from community partners; i.e, MUUSJA, UU Social Justice; Side with Love campaigns, etc. Will forward those to ministerial liaisons as appropriate.

Our COMT would like to be able to represent Unity Church Unitarian in the public sphere.

This is an important question – not only for our Community Outreach Ministry Teams, but for many programs and initiatives in the church that feel called to witness in the larger community. To guide our deliberations, the Executive Team has consulted with both the UUA, the Office in Washington, our own Governance Policies and the IRS limitations on non-profit organizations. The attached document is our current policy and best practices on how the church can respond to the political demands of our time.

We used to have a dedicated staff member to oversee the COMT's. What's the plan?

We have not budgeted for a dedicated staff member to oversee the COMT's in the 2024 budget year. However, the newly re-designed Membership Coordinator/Programs Assistant portfolio (as of yet unfilled) has responsibility for some administrative oversight of the COMT's.
