

Review of *Gather for the Earth* Responses

On February 29, 2020, members of Unity Church-Unitarian met to share concerns and responses to the current state of the environment. This *Gathering for the Earth* was moderated by the Sustainable Living Team, or SLT. The intention of this document is to compile responses from that meeting in a way that can inform the ministry of the SLT and Unity Church-Unitarian to further environmental and climate justice and sustainability. The SLT will develop a Green Sanctuary Action Plan for the congregation reflecting the wishes of the congregation as expressed by these results.

We are grounded in this work by the **Seventh Principle of the UUA:**

“Respect for the interdependent web of all existence of which we are a part”

And by our own congregation’s **Ends** statements:

“Discover and pursue our individual and collect work to advance justice, wholeness, and equity for people, our Earth and all life on it.”

And by the SLT mission statement:

“To help Unity Church-Unitarian become a leader in climate action, environmental justice and sustainable living through education, hands-on projects, policy initiatives and opportunities for reflection and celebration”

Four main themes emerged from the meeting, and are listed below as **OUTCOMES**. Each outcome is followed by **STRATEGIES** proposed by *Gather for the Earth* participants, ranked in order according to the number of times the idea was brought forward. (We anticipate additional strategies will emerge as we formulate the Action Plan.)

The four themes, or **OUTCOMES**, are:

- Congregants are sustained spiritually for the work of environmental and climate justice and sustainability
- Individuals make wise choices and act for environmental and climate justice and sustainability.
- The church community acts for environmental and climate justice and sustainability.
- Long-term partnerships inform, enhance, and leverage our work and assist in influencing public policy and furthering social justice work.

Outcome 1

Congregants are sustained spiritually for the work of environmental and climate justice and sustainability.

Strategies:

- Build support groups so that people can walk the walk collectively and know how their individual acts add up. Be accountable to one another for the work.
- Invite indigenous communities to share their perspective with the congregation about indigenous spiritual practice that connects people to the land.
- Acknowledge, with humility, our place in the interconnected web of existence.
- Maximize opportunities to build spiritual practices, express grief and find hope in worship and religious education.
- Create opportunities to connect with and enjoy nature.
- Take action purposefully and mindfully.

Outcome 2

Individuals make wise choices and act for environmental and climate justice and sustainability.

Strategies:

- Create opportunities to empower congregants to learn about and engage in wise choices:
 - Make information and sustainable practices accessible for the congregation
 - Communicate monthly environmental practices aligned with the worship theme.
 - Share tips regularly and create an ongoing, easily accessible list.
 - Teach people the 6 Rs: reduce, reuse, recycle, refuse, repair, repurpose
 - Help congregants use alternative forms of transportation (bikes, public transit)
 - Help congregants share their environmental skills with each other
 - Provide a clearinghouse for ways individuals can act to support policy issues.
 - Show people how to act in alignment with appropriate land stewardship (pollinator gardens, land use in development, balancing conflicting values in land use, planting trees, food production, use of farmland)
 - Teach people about divestment from fossil fuels.
 - Learn collectively about this land's history (i.e. Dakota land) and our historical, cultural connection to nature. (your historical and cultural connection)
 - Create opportunities to steward the land.

- Track whether people are making wise choices and acting (congregational survey?)
- Celebrate success in individual choices and action.

Outcome 3

The church community acts for environmental and climate justice and sustainability.

Strategies:

- Find collective actions for the congregation:
 - Plant trees
 - Collect funds for a particular purpose
 - Assess the church's investment in the work (green minister? Money invested? Time invested?)
 - Set up a carpool program
 - Help people use their gifts, talents, and resources in the work.
- Implement best sustainability practices at the church to act in alignment with environmental values and as a model for what's possible in environmental sustainability and as education for others (individuals, institutions, and the community), including:
 - Audit the church's carbon footprint
 - Aim for net zero carbon use: Clean energy, Solar on the church
 - Grounds/greenspace pollinator garden
 - Divest from fossil fuels (probably already done; check with Barbara)
- Collectively endorse a broad and proactive policy for environmental and climate justice and sustainability (e.g., the Green New Deal or the Minnesota 100 percent).
- Integrate environmental and climate justice and sustainability education into all areas the church educates (Religious Education, Wellspring Wednesday, etc.)
- Connect environmental justice work with other justice work the church does.
- Assess the results of this work.
- Celebrate and publicize successes and process, particularly what we're already doing.

Outcome 4

Long-term partnerships inform, enhance, and leverage our work and assist in influencing public policy and furthering social justice work.

Strategies:

- Create and sustain partnerships, [in humility] that inform our work:
 - Indigenous people
 - Youth
 - Other traditionally marginalized and oppressed communities
- Create and sustain partnerships that enhance:

- U of M
- Frogtown Green
- Transition Towns
- Ramsey County and City of St. Paul
- MNIPL
- CUB (Community Urban Builders?)
- MN Council of Churches
- Obama Elementary
- House of Hope Church
- Create and sustain partnerships that assist in influencing public policy
 - MNIPL
 - MN state legislature and departments
 - Ramsey County and City of St. Paul
 - Other environmental advocacy groups
- Create and sustain partnerships that assist in furthering social justice work:
 - Poor People's Campaign
 - Indigenous and other marginalized people
